Bylaw D: Trophies and awards

1. Special and specific Trophies award criteria

1.1 The “Masters-four” trophy

A Master’s team will consist of 4 members qualifying for Masters division as per the constitution criteria. The four anglers achieving the 4 best scores in a member club will qualify as the club’s “Masters-four” team on the competition day.

1.2 Sir Drummond Chapman trophy

Each member club will nominate 4 anglers to compete. A list indicating the names of the 4 anglers should be handed in at the Captains meeting on the day of the January competition.

1.3 Wallace van Wyk trophy

The “A” team scoring the most points during the first February Interclub competition

1.4 Piet Alberts trophy

Junior Champion of first Interclub of season

1.5 The Blue Ray Trophy (most consistent angler)

This award shall be for the Top Angler across all divisions, measured on the position-ranking points (not proportioned to top-weight per competition) for all the Inter Club competitions that counts for points, i.e. 7 out of 8.
